**REGISTRATION PLATES FEES (Find your fee under the proper classification)**

PRIVATELY OWNED VEHICLES –	Classes identified below will be registered for 2 years at the time they are titled or when their registration is renewed. The 2 year registration does not apply to Class E, truck vehicles in excess of 7,000 pounds.
COMPANY OWNED VEHICLES –	Registration issued annually at the 1 year fee. Half-year rates are effective on or after the first day of the seventh month of the registration year. Quarterly rates are in effect for trucks 27,000 lbs. or more.
SURCHARGE –	To insure stable funding for Maryland's world-renowned emergency medical services (EMS) system, including med-evac helicopters, ambulances, fire equipment, rescue squads and trauma units, a "surcharge" of \$13.50 per year will be collected with the registration fee. The following fees include the surcharge where applicable.
PAYMENT –	Check or money order payable to MVA. The check must include (1) Imprinted Name and Address, (2) Drivers License Number (Soundex Number), (3) Home or Work Telephone Number.
